

**TERMS AND CONDITIONS  
GREENWOOD PLAZA AUGUST FOOD INSTANT WIN AND MAJOR PRIZE

**PROMOTION PERIOD**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this August Food Promotion ("**Promotion**") is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in (NSW) local time.
2. Subject to condition 3, this Promotion is only open to Australian (NSW) Residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.

## **GENERAL**
