

TERMS AND CONDITIONS FOR GREENWOOD PLAZA INSTAGRAM GIVEAWAY PROMOITON

1. Information on how to enter and prizes form part of these Terms and Conditions.
Participation in any **GREENWOOD PLAZA INSTAGRAM GIVEAWAY** Promotion ("Promotion") is deemed acceptance of these Terms and Conditions. All times and dates throughout these Terms and Conditions will be based on **(NSW)** local time. The "Participating Centre" is **GREENWOOD PLAZA NORTH SYDNEY**
2. Subject to condition 3, this Promotion is only open to **NSW** Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions.
